ORDER

Sri. Suresh P.M, Payyanichottil, Bison Valley is a registered consumer with consumer No.1156155005893 under Electrical Section Chithirapuram. Owing to non remittance of Electricity bill since 01/2003, the service connection to the above premises was disconnected. Later steps were taken for Revenue recovery. Even though notice was issued to the said consumer based on OTS 2018 on 06.07.2018, he did not turn up owing to his financial difficulty.

The consumer has approached KSEBL, vide letter dated 14.03.2019, for settlement of the arrear amount in OTS. The principal amount of Rs. 52,600/- and an amount of Rs. 60,006 towards surcharge under OTS scheme is to be remitted by the consumer for the period from 01 /2003 to 03/2019.

The matter was placed before the Full Time Directors vide note read as 4 above.

Having examined the matter in detail , the Full Time Directors in the meeting held on 11.04.2019 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Thodupuzha to settle the arrears in respect of Sri. Suresh P.M., Payyanichottil with consumer No 5893 of Electrical Section, Chithirapuram under OTS Scheme by remitting the principal amount in lumpsum with interest at a reduced rate of 6% along with collection charges payable to Revenue Department, considering it as a special case.

Further resolved to direct the Deputy Chief Engineer, Electrical Circle, Thodupuzha to inform the settlement details to the Deputy Chief Engineer (Commercial and Planning) with full Powers of Chief Engineer.

Also, resolved to authorize the Deputy Chief Engineer (Commercial and Planning) with full powers of Chief Engineer to take up with the Hon'ble Kerala State Electricity Regulatory Commission for an ex-post facto approval on the matter.

Orders are issued accordingly.
