### ORDER

The KSEBL vide B.O read as 1<sup>st</sup> paper above had accorded sanction to hand over 9.5 ares of land (23.47 cents) in survey No. 1238/2 of Chittar-Seethathode village under possession of KSEBL, to State Police Department for the construction of Moozhiyar Police Station on remittance of value of the land and cost of two buildings amounting to Rs.7,73,142/- (Rupees Seven Lakh Seventy Three Thousand One Hundred and Forty Two only)as fixed by by the District Collector, Pathanamthitta. The Government vide GO (RT) No.3170/2015/Home dated 08.12.2015 had accorded Administrative Sanction to the State Police Chief for proceeding further for getting transferred the 9.5 ares (23.47 cents) of land ,by remitting Rs.7,73,142/- and the amount was transferred to KSEBL through NEFT on 15.10.2016.

The handing over of land in possession of KSEBL to the State Police Department was delayed due to lack of proper land records. Now the Government vide letter read as 2<sup>nd</sup> paper above has directed KSEBL to issue proceedings for surrendering the 9.5 ares of land (23.47 cents) in survey No. 1238/2 of Chittar-Seethathode village under the possession of KSEBL, to the Power Department for the construction of Moozhiyar Police Station. It is also informed that

Government orders transferring this land to Revenue Department will be issued from Power Department to follow the procedural requirement suggested by Revenue Department for the sake of land records.

A proposal in this regard was placed before the Full Time Directors as per note read as 3<sup>rd</sup> paper above. Having considered the matter in detail, the Full Time Directors of the KSEBL in the meeting held on 28.06.2019, resolved to accord sanction to issue a proceedings to surrender the 9.5 ares of land (23.47 cents) in survey No. 1238/2 of Chittar-Seethathode village under possession of KSEBL for the construction of Moozhiyar Police Station to the Power Department. Further resolved to approve the draft proceedings annexed.

Orders are issued accordingly.
