ORDER

Sri. Unnikrishnan, Lineman grade I of Electrical Section, Perinthalmanna submitted a mercy petition before KSEB Ltd to shift him to the post of Office Attendant at the Division Office since he has been suffering from trauma of serious electrical accident occurred during supply restoration works in 2014 describing his inability to physically perform the duties and functions associated with LM – I. Instead, he expressed willingness to perform the duties that is possible of being done by him within the limitation of disablement sustained and has requested to shift him to any other suitable post.

The standing disability assessment Board certificate issued from the District Medical Board, Perinthalmanna certifies that Sri. Unnikrishnan is handicapped by electrocution injury leading to right elbow amputation, scarring of left chest and the total disability is 70%. Owing to such a disablement of the lack of dexterity of his fingers and imbecility of his left hand he could not perform the duties assigned to him

In the above context, the request of Sri. Unnikrishnan to provide alternate duties and responsibilities capable of being performed by him in view of the 70% disablement sustained during the course of employment has been evaluated by KSEB Ltd subject to the provisions contained in Persons with disabilities (Equal opportunities, Protection of rights and full participation) Act, 1995

Having considered the above, sanction is hereby accorded to create a supernumerary post of Office Attendant at Electrical Division Office Perinthalmanna by invoking section 47(1) to (2) of the persons with disabilities (Equal Opportunities, Protection of rights and full participation) Act, 1995, for the limited purpose of posting Sri. Unnikrishnan against the post. Provided further that Sri. Unnikrishnan so posted as Office Attendant at Electrical Division Office, Perinthalmanna shall be retained at that office and the supernumerary post created in this behalf to Sri. Unnikrishnan shall be abolished as and when one of the present Office Attendants is shifted.

Orders are issued accordingly.
