ORDER

As per Board Order read above, Sri.Sunny Joseph, Volleyball Coach (Retd.), Kerala State Sports Council was re-engaged as Coach of the KSEB Volleyball (Women) team for a period of one year w.e.f. 15th July 2018. Since the period of his engagement expired on 14th July 2019, the Sports Co-ordinator vide note read above has suggested to re-engage him for a further period of one year w.e.f. 15th July 2019. It is also suggested to utilize the service of Sri,Sunny Joseph for the KSEB Volleyball (Men) team temporarily for a period of two months w.e.f. 15th July 2019 since the coach of the Volleyball (Men) team is unable to take up the assignment for two months due to personal reasons.

Having considered the note, the Full Time Directors in its meeting held on 24-07-2019,

Resolved to accord sanction for the re-engagement of Sri.Sunny Joseph, Volleyball Coach (Retd.), Kerala State Sports Council as Coach of the KSEB Volleyball (Women) team for a further period of one year w.e.f. 15th July 2019 as per the existing terms and conditions as given below.

- i) He will be paid a monthly Honorarium of Rs.25,000/- (Rupees Twenty Five Thousand only), Daily Allowance @ Rs.150/- per day for the actual coaching days and Diet Allowance @ Rs.75/- per session for actual coaching sessions during the period of engagement.
- ii) He will be eligible for TA/DA as applicable to the sports persons for accompanying the Board's team in official obligatory tournaments.
- iii) The above engagement can be terminated by the Board at any time.

Further resolved to utilize the service of Sri.Sunny Joseph for a period of two months with effect from 15th July 2019 temporarily for the KSEB Volleyball (Men) team.
