### ABSTRACT

Bye-election to 093 - Pala Legislative Assembly Constituency – Declaration of holiday on the day of Poll (23<sup>rd</sup> September 2019) to the Offices of KSEBL in the area covered by the Constituency and granting permission for Employees to avail a paid holiday on the day of Poll who are voters in Pala Assembly Constituency and are working in offices of the KSEBL situated outside the constituency – Sanctioned - Orders issued.

### ORDER

The Government of Kerala, vide Order read above (G.O (Ms) No.174/2019/GAD dated 04.09.2019) have declared Monday, the 23<sup>rd</sup> September 2019 as a public holiday for all Public Offices and Educational Institutions and a paid holiday for all Government / Quasi Government and Commercial Establishments in the area covered by the Constituency in connection with the Bye-election to the 093 – Pala Legislative Assembly Constituency. It is also stated that, “ Employees including casual workers who are ordinarily resident of the above Constituency where Poll is taking place and registered as an elector, in that Constituency but serving / employed in an Industrial undertaking or an establishment located outside the Constituency where he / she is resident have to be given the benefit of paid holiday on the day of Poll”.

In line with the above, the Kerala State Electricity Board Limited is also pleased to declare 23<sup>rd</sup> September 2019 (Monday) as holiday for all its offices falling within the Pala Legislative Assembly Constituency limits. Employees of KSEB Limited who are voters in Pala Legislative Assembly Constituency and are working in offices of the KSEBL situated outside the constituency would also be eligible for a paid holiday on the election day.

However, all field officers are directed to ensure the availability of essential staff to maintain uninterrupted power supply through out Pala Legislative Assembly Constituency with necessary alternate arrangements so as to enable the staff to exercise their franchise on the date of poll.
