ORDER

As per 3rd paper read above, the Deputy Chief Engineer, Electrical Circle, Harippad forwarded applications from two Cable TV Operators under Electrical Division, Haripad, viz. Sri. Salahudheen. Cresendo Cable Network & Brasnbo Cable Network and Sri. Sanjay S, Saj Cable Network, requesting for remitting pole rent and its arrears in installments under OTS scheme as per B.O. read as 1st paper above.

As per the details furnished by the Deputy Chief Engineer, Electrical Circle, Harippad. pole rental arrear due from Sri. Salahudheen for the years 2011-12, 2012-13, 2016-17, 2017-18 & 2018-19 as on 15.05.2019 is Rs.1,20,020/- for the case of Cresendo Cable Network, under Electrical Section. Karthikapally and is Rs.39,004/- for the case of Brasnbo Cable Network under Electrical Section Arattupuzha. The request of Sri. Salahudheen is to waive the interest amount and sanction 12 installments. As per the report received as per letters read as 2nd and 3rd paper above. Sri. Salahudheen and his wife are Cancer patients and facing financial problems.

As per the details furnished by the Deputy Chief Engineer, Electrical Circle, Harippad. pole rental arrear due from Sri. Sanjay S, Saj Cable Network, Ummermukku, Muthukulam under

Electrical Section, Muthukulam for the years 2011-12, 2012-13, 2016-17, 2017-18 & 2018-19 is Rs.1,34,853/- as on 13.05.2019. The request of Sri. Sanjay S. was to sanction 12 installments.

The Deputy Chief Engineer, Electrical Circle, Harippad reported that both the cases are eligible to get installments under OTS Scheme and hence requested to sanction installments for both principal and interest portion of pole rental arrears, under OTS Scheme.

The matter was placed before the Full Time Directors as per note read as 4th paper above. Having examined the note and after having detailed deliberations, the Full Time Directors in the meeting held on 27.09.2019 resolved to accord sanction to consider the requests of Sri. Salahudheen(Cresendo Cable Network under Electrical Section Karthikapally & Brasnbo Cable Network under Electrical Section Arattupuzha) and Sri. Sanjay S(Saj Cable Network, Ummermukku under Electrical Section, Muthukulam) for allowing installments for the pole rental arrears aging more than 2 years as on 31.03.2019, under OTS Scheme as per B.O. read as 1st paper above.

Further resolved to accord sanction for the following:

- i. to allow a maximum of **12 (twelve)** months equal installment to **Sri. Salahudheen** (Cresendo Cable Network under Electrical Section Karthikapally & Brasnbo Cable Network under Electrical Section Arattupuzha) for both the principal & interest amount of pole rental arrears aging more than 2 years as on 31.03.2019, with an applicable interest (for the principal amount alone) rate of 12% of the installment period.
- ii. to allow a maximum of **12 (twelve)** months equal installments to **Sri. Sanjay S.** (Saj Cable Network, Ummermukku under Electrical Section, Muthukulam), for both the principal & interest amount of pole rental arrears aging more than 2 years as on 31.03.2019, with an applicable interest (for the principal amount alone) rate of 12% of the installment period.
