ORDER

In the 10th State Level Monitoring Committee meeting held on 01.01.2019 chaired by the Chief Secretary, Government of Kerala, it was decided that the survey of Forest Land leased out to KSEBL shall be completed in a time bound manner through a joint exercise with the Forest Department at the cost of KSEBL Ltd. In line with this decision KSEBL as per B.O read as 1st paper above has directed all the custodians of Forest land leased out to KSEBL to get the entire extent of forest land under their jurisdiction surveyed and demarcated on ground.

For the smooth progress of works and tasks entrusted with KSEBL by the State Level Monitoring Committee, joint and effective co-ordination between the line departments viz Revenue, Forest & KSEBL is highly essential. KSEBL as per office order read as 2nd paper above has accorded sanction to utilize the service of Sri S. Rajeeve, RDO (Retd) for a minimum period of six months from March 2019 for providing necessary assistance for the subject work. Also KSEBL as per B.O read as 3rd paper above has fixed the remuneration of

Sri S.Rajeeve. RDO (Retd) @ Rs 50,000/- (Rupees Fifty Thousand Only) inclusive of all expenses.

The Chief Engineer(C-I&CC) as per note read as 4th paper above has reported that Sri S.Rajeeve, RDO (Retd) had commenced the activities entrusted by that office w.e.f March 2019. The joint inspection with the help of forest officials has been completed in almost all the extent of forest land in possession of KSEBL and tendering of works related to survey of forest land are now progressing.

The Chief Engineer(C-I&CC) recommend to extend the period of utilization of services of Sri S Rajeeve, RDO (Retd) for a further period of six months or till the exercise of survey & demarcation of forest land in possession of KSEBL is completed whichever is earlier and all other terms & conditions of appointment remaining the same.

The matter was placed before the Full Time Directors in the meeting held on 27/9/2019 as per note read as 5th paper above.

Having considered the matter in detail, the Full Time Directors Resolved to accord sanction to utilize the services of Sri S Rajeeve, RDO (Retd) for providing necessary assistance in the task of survey & demarcation of forest land in possession of KSEBL for a further period of six months or till the exercise of survey & demarcation of forest land in possession of KSEBL is completed, whichever is earlier.

Further resolved to apply the terms & conditions of appointment for the period from September 2019 as in the Office Order (CMD) No: 329/2019 (DGC / AEEV / Forest /2014) dated 18.2.19 & B.O(FTD) No: 259/2019(DGC/AEEV/Forest/2014) dated 18.3.2019.

Orders are issued accordingly.


