ORDER

The Government of Kerala, vide Order read 1st above (G.O (Ms) No.174/2019/GAD dated 04.09.2019) have declared Monday, the 23rd September 2019 as a public holiday for all Public Offices and Educational Institutions and a paid holiday for all Government / Quasi Government and Commercial Establishments in the area covered by the Constituency in connection with the Bye-election to the 093 – Pala Legislative Assembly Constituency. It is also stated that, “Employees including casual workers who are ordinarily resident of the above Constituency where Poll is taking place and registered as an elector, in that Constituency but serving/employed in an Industrial undertaking or an establishment located outside the Constituency where he / she is resident have to be given the benefit of paid holiday on the day of Poll”.

Having considered the matter in detail, the Chairman & Managing Director, has given orders to adopt the same for implementation in KSEB Ltd and an Office Order (CMD) No.1647/2019 (PS1 (B)/3609/2018) TVPM dated 19.09.2019 has been issued read 2nd above. As per the above order, a holiday has been declared on the day of Poll (23rd September 2019) to the offices of KSEBL in the area covered by the Pala Legislative Assembly Constituency and Permission granted to Employees for availing a paid holiday on the day of Poll who are voters in Pala Legislative Assembly Constituency and are working in offices of the KSEBL situated outside the constituency. Also all field officers are directed to ensure the availability of essential staff to maintain uninterrupted power supply through out Pala Legislative Assembly Constituency with necessary alternate arrangements so as to enable the staff to exercise their

The matter was placed before the Full Time Directors vide the note read as 3rd paper above for ratification.

Having examined the matter in detail, the Full Time Directors in the meeting held on 09.10.2019 resolved to ratify the issuance of the Office Order read 2nd above adopting G.O read 1st above.


