ORDER

The tender for empanelment of EPC / RESCO contractors for the 1st Phase of Soura Project (200 MW) had been floated on 6.9.2019. The bid submission is scheduled upto 16.10.2019, PQ bid opening is scheduled on 21.10.2019 and Financial Bid opening on 21.11.2019.

The pre-bid meetings of the tender were conducted on 19.9.2019 at New Delhi and on 5.10.2019 at Thiruvananthapuram. The clarifications to the queries raised by the firms and corrigendum on bid conditions is published on 11.10.2019.

Several firms which participated in the above meetings had requested for extension of bid submission date in order to obtain necessary approvals from their head offices. Also requests were received vide E-mails for extension of the bid submission date.

The matter was placed before the Chairman and Managing Director, KSEBL to decide whether the bid submission date may be extended for **one week** from 16.10.2019 to 23.10.2019, consequently the PQ bid opening to 28.10.2019 and Financial Bid opening to 28.11.2019.

The Chairman and Managing Director, KSEBL approved the extension of bid submission and opening dates as above. It was also directed to place the matter before the Full Time Directors for ratification. Accordingly the matter was placed before the Full Time Directors as per note under ref (2).

Having considered the matter, the Full Time Directors in the meeting held on 16.10.2019 resolved to ratify the action of State Nodal Officer, Soura Project in having extended the last date for submission of bids in the Tender No. /1/Soura-200 MWp/2019-20 from 16.10.2019 to 23.10.2019 , the PQ bid opening date from 21.10.2019 to 28.10.2019 and Financial Bid opening from 21.11.2019 to 28.11.2019.

Orders are issued accordingly.


