ORDER

Smt. Valsala Kumari.T.C, Senior Assistant, Electrical Section, Muduvara, Thrissur joined in KSEB Ltd service on 13.03.2001 as Cashier. She had prior service in land revenue Department from 31.07.1999 to 09.03.2001. The above Revenue service was reckoned and recorded in the Service Book of the incumbent by the Accounts Officer (Pension Authorization). She is due to retire on 31.07.2019. Smt. Valsala Kumari. T.C in her request reported that she was instructed to report for duty at RPTI, Poochatty on 12.03.2001. Hence she was relieved from Land Revenue Department on 09.03.2001, 10.03.2001 was second Saturday and 11.03.2001 was Sunday. She reported for Training at RPTI on 12.03.2001, but the training programme was postponed to 13.03.2001 due to 'Hartal' announced by political parties. Hence there occurred a break of one day between the two services. Now Smt. Valsala Kumari has requested to condone the break on 12.03.2001 vide 1st paper read above. The Deputy Chief Engineer (HRM) I also requested clarification in this regard vide note read as 2nd paper above.

In a similar issue (Sri. John.K.V, Senior Assistant) KSEB Ltd had accorded sanction to condone the break of 4 days from 09.03.2001 to 12.03.2001 between his service in Police Department and KSEB Ltd vide 3rd paper read above.

The matter was placed before Full Time Directors vide 4th paper read above.

Having considered the matter, the Full Time Directors in the meeting held on 24.06.2019 resolved to accord sanction to condone the break in service on 12.03.2001 in respect of Smt. Valsala Kumari.T.C, Senior Assistant as a special case in line with the Board Order dated 10.07.2009.
