ORDER

M/s. Kakkanad Government Servants Hostel, a consumer under Electrical Section, Thrikkakara West under Electrical Circle Ernakulam is having a pending arrear amount of Rs.29,64,628/- (bill amount Rs.5,48,916/-+ interest of Rs. 24,15,712/-) for the period from 27.07.2000 to 30.11.2018. The same was included in the last year OTS Scheme and the arrear amount was calculated as Rs.11,53,114/-. However, the consumer did not remit the amount.

The Executive Engineer, Public Works Department (Building), Edapally Ernakulam informed that the amount could not be remitted as the same was not released from the Government on time. Presently, the Chief Engineer (PWD) has sanctioned the amount and if the same is not remitted before 11.10.2019, it will be lapsed. Hence, has requested to permit them to remit the amount.

The Deputy Chief Engineer, Electrical Circle, Ernakulam, as per letter read 1 above, has informed that as the time limit for OTS 2018 has been expired, there are technical difficulties in collecting the amount in the Section Office. Moreover, if the request of the Executive Engineer, PWD is not considered favorably, the realization of the arrear amount might further get delayed, as it being a Government Department. The Kerala State Electricity Regulatory Commission, as per letter read 2 above, has approved the 'One Time Settlement Scheme 2019 (OTS 2019)' for the period from

01.10.2019 to 31.01.2020. The matter was placed before the Full Time Directors as per note read 3 above.

Having examined the matter in detail , the Full Time Directors in the meeting held on 09.10.2019 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Ernakulam, to settle the arrear amount against the consumer Kakkanad Government Servants Hostel bearing consumer No. 1157311019095 under Electrical Section, Thrikkakara West, at reduced interest rate, as per the 'One Time Settlement Scheme 2019 (OTS 2019)', approved by the Kerala State Electricity Regulatory Commission, as a special case considering it as a Government Institutions.

Orders are issued accordingly.


