ORDER

Government have introduced National Pension System (NPS) to the All India Service (Kerala Cadre) officers recruited on or after 01-01-2004 vide Government order read as 1st paper above and this scheme has been made applicable to the state employees who are appointed into the service on or after 01-04-2013 vide Government order read as 2nd paper above. Moreover Government have issued the guidelines and accounting procedures for the realization of backlog contributions in respect of National Pension System for the All India Service (Kerala Cadre) Officers and State Employees to whom NPS is applicable in Government Departments vide Government order read as 3rd paper above. The employees are given freedom to remit their pending backlog contribution either through equal monthly installment (EMIs), equal multiple installments or lump sum payment. For that, the number of EMI allowed for the All India Service Officers shall be 50(Fifty) and the number of EMI allowed for the state employees/employees under state autonomous bodies shall be 15(Fifteen). Later vide Government order read as 4th paper above, Government have issued the guidelines for the realization of backlog contributions in respect

of employees of PSUs/Autonomous bodies/Boards/Universities limiting the number of installments to the difference of the number of months from the date of implementation of NPS and commencement of deduction of NPS contribution. Since most of the newly recruited employees coming under NPS belong to low paid categories the Secretary (Administration) of KSEB Ltd. Vide letter read above has requested Government to enhance the number of EMIs to 30.

Government have examined the matter in detail. Considering the fact that KSEB have already started online PRAN generation and deduction of regular contribution as well as backlog contribution and NSDL have appreciated the remarkable service rendered by them, Government are pleased to enhance the number of EMIs from 15 (Fifteen) to 30 (Thirty) to employees of KSEB Ltd. by relaxing the orders issued vide order read 3rd above so as to realise the backlog contribution effectively.
