The Kerala State Electricity Board Limited has revised the Pay and Allowances and pensionary benefits of its officers and workmen with effect from 01.07.2013/01.08.2013 respectively vide orders read 1st and 3rd papers above. The revision of pension and allied benefits of Part Time Contingent pensioners was deferred since the same has not been revised in Government eventhough the scale of pay of PTC employees have been revised with effect from 01.08.2013.

Later when the Government have revised the pension and allied benefits of PTC pensioners vide Government Order read as 2nd paper above, the Full Time Directors of KSEB Limited ordered to revise pension and other related benefits of Part Time Contingent pensioners with effect from 01.08.2013 and orders were issued vide B.O. read on 4th above.
