TERMS AND CONDITIONS

- I. All communications shall be addressed to the Executive Engineer, Lower Periyar Generation Division, Karimanal, Thattekkanni P.O., Idukki District-685 606.
- II. All bidders participating in the tender should have a valid Digital Signature Certificate availed from an approved certifying authority. All communications regarding the tender including queries if any shall be done online at the website www.etenders.kerala.gov.in.
- III. The bid documents and other details may be downloaded from the website www.etenders.kerala.gov.in. The EMD of Rs 30,300/- (Rupees Thirty Thousand Three Hundred Only) and the non-refundable bid submission fee of Rs.2950 /-(inclusive of GST @ 18%) i.e., a total of Rs 33,250/-(Rupees Thirty Three Thousand Two Hundred Fifty Only) shall be remitted online through internet banking only. **Bidders should ensure that bid submission fees and EMD are remitted as one single transaction and not as separate payments.** Separate or split remittance for bid submission fee and EMD shall be treated as invalid transactions. The online payment may be exercised at least 48 hours before the closing date of the bid to ensure that payment towards tender document fee and EMD are credited to the beneficiary account and a confirmation is reflected in the e-procurement system.
- IV. The offers shall be submitted in single bid system. All bid documents are to be submitted online and in the designated covers/envelops on the above website. Bids shall be accepted only through online mode in the website and no manual submission shall be entertained.

The scanned copies of EMD, all agreements executed in Kerala Govt. stamp paper worth Rs. 200/- each and all certificates/documents mentioned elsewhere in the bid documents are to be attached along with the bid through online mode. The bids will be opened online at the office of the Executive Engineer, Lower Periyar Generation Division, Karimanal on the date and time mentioned above or modified and communicated through corrigendum.
- VI. Originals of all agreements in Kerala Govt. stamp paper and other documents, enclosed in a sealed envelope indicating E-Tender ID No. 2023_KSEB_622753 and 14/ e Tender/LPGD/2023-24/16-11-2023, shall be submitted to Executive Engineer, Lower Periyar Generation Division, Karimanal, Idukki Dist, Kerala, Pin - 685606 immediately within bid opening date.
- VII. After evaluation of the bids, the successful bidder shall execute an agreement in the form prescribed by KSEBL for the due fulfillment of the contract within the period to be specified in the workorder and shall furnish a security deposit equal to 5% of the contract value before signing the agreement. Tenderers should be prepared to accept orders subject to an indemnity clause for forfeiture of security deposit in the event of default or failure to execute the work within the stipulated period.
- VIII. The rate quoted shall remain firm for six months from the date of opening of the bid. The rate should be quoted as per format given in the E-tender portal.
- IX. All other existing conditions related to the tenders of KSEB Ltd will be applicable to this E-tender also. The bidding authority reserves the right to modify/cancel any or all bids without assigning any reasons.
