## **ORDER**

The Board vide B.O. read as 2<sup>nd</sup> paper above had accorded sanction for the CDM development of three pilot projects viz. Vilangad SHEP (7.5 MW), Chathankottunada SHEP (6 MW) and Kakkayam SHEP (4 MW), as per the Agreement executed with M/s. SMEC for the CDM Advisory Services, vide 1<sup>st</sup> paper read above.

2. The Chief Engineer (Corporate Planning) vide 3<sup>rd</sup> paper above has reported that for the finalisation of Project Design Documents, stakeholder consultation is mandatory as per the CDM modalities. The Chief Engineer (Corporate Planning) has therefore suggested to arrange stakeholder meetings on ground with due publicity by publishing invitation notice in the local dailies. Necessary documents including project details are to be made available in KSEB's web site, site offices and other important offices of KSEB in the locality for facilitating access for the stakeholders to the documents.

3. In view of the above, sanction is accorded for conducting stakeholder meetings at the project sites for Chathankotunada, Vilangad and Kakkayam SHEPs as part of CDM requirements and for publishing the project details and other necessary documents in the KSE Board's website for facilitating access to the stakeholders to the documents. The responsibility for conducting the field activities with respect to the stakeholder meetings is entrusted with the respective Project Managers and to incur expenditure thereon. The KSEB CDM team shall be present in all the meetings conducted at the sites.

4. The Chief Engineer (Corporate Planning), Chief Engineer (Civil Construction) North and the concerned Project Managers shall take further necessary action in this regard.
