ORDER

Section 55 of the Electricity Act, 2003 mandates that the licensee shall supply electricity only through a correct meter in accordance with the regulations framed by the Central Electricity Authority (CEA). As per Notification read as 2nd paper, the Central Electricity Authority issued the Central Electricity Authority (Installation and Operation of Meters) Regulation, 2006. Clause 17(2) of the above regulation requires licensees to get the accreditation of the meter testing laboratories from the National Accreditation Board of Testing and Calibration Laboratories (NABL).

The KSE Board therefore decided to obtain accreditation to its Meter Testing Units. The Executive Engineer, TMR Division, Angamali has visited the Central Power Research Institute, a Government of India Enterprises with NABL certification in this connection. The Executive Engineer, TMR Division, Angamali reported vide paper read as 3rd that, ISO Certification is necessary for getting accreditation of NABL. The Board considered the matter and pleased to issue sanction for engaging consultancy for obtaining ISO Certification to the Meter Testing Units of KSE Board.

Therefore, it is ordered that the Executive Engineer, TMR Division, Angamali shall take immediate steps to engage a competent consultant for the purpose of getting ISO Certification to the TMR Division, Angamali for the purpose of obtaining NABL accreditation, in consultation with the Board.


