## ORDER

Sri. K. Sundaran, Chief Engineer, Building and Local Works and Ex-officio Additional Secretary to Government, Public Works Department has informed that the disconnection of power supply to PWD Rest Houses due to the non-payment of electricity charges causes extreme hardships as the PWD Rest Houses are being occupied by the Ministers and other top officials including Judicial Officers, Commissions for holding enquiry proceedings etc. It is stated that by the end of the financial year, the dues will be almost cleared. The Chief Engineer requested not to disconnect the power supply of the PWD Rest Houses abruptly and without due notices to the concerned with sufficient time.

Having examined the matter, sanction is accorded to give time extension up to 31.03.2008 to remit the arrear electricity charges of PWD Rest Houses and various offices of the PWD (B& LW) existing as on 31.12.2007. The PWD shall be insisted to remit the regular electricity charges from 01.01.2008.
