ORDER

As per the Board Order read as 1st above, all unauthorized CTV connections can be regularized with effect from the date of payment of 3 times the floor rate fixed by the Board from the date of unauthorized connection and the cut off date for regularizing the unauthorized connection was fixed as 01.11.2002. Later it was extended upto 31.12.2006 vide Board order read as 2nd and 3rd above.

The Member (Distribution) vide note read as 4th above has suggested to revise the cut off date for regularization of unauthorized CTV connections upto 31.03.2008, since a large number of unauthorized connections are existing and will help to realize a considerable revenue to the Board.

Having considered the matter in detail, sanction is accorded to:

- (i) regularize all unauthorized CTV connect ions except that of M/s. Asianet Satellite Communications with effect from the date of payment of three times the floor rate fixed by the Board from the date of unauthorized connection.
- (ii) (ii) The cut off date for regularizing the unauthorized connection is fixed as 31.03.2008.
- (iii) The Executive Engineers of Electrical Divisions should give wide (iii) publicity regarding this and should remove all unauthorized connections, which have not been regularized as per this order.
