ORDER

Government vide Government order read as 1st paper had ordered waiver of minimum demand charges for electricity for the period of closure in respect of all closed Plantations and Industrial units which will be restarting their operation on or before 30.06.2007.

- (1) Board hereby accord sanction to adopt the G.O. (Rt) No: 35/07/PD dated 24.02.2007 for implementation in the Board subject to the conditions that:
- a) Government order shall be applicable only to the units reopening on or before 30.06.2007 and subject to the condition that the package for repayment will be considered by the Board by processing individual cases of plantations and industrial units on production of a certificate regarding closure and reopening obtained from the competent Authority.
 - b) If there are more than one spell of closure intervened by a spell of operations, the last spell of closure only will be taken for granting waiver of MD charges as per (a) above.
 - c) Reconnection will be given only on payment of the arrears, if any, for the period prior to the period for which MD charges are waived.

- (2) Board also decided to obtain clarification order in the case of closed LT industrial units, which have to pay fixed charges.
- (3) Also, decided to file a petition before the Kerala State Electricity Regulatory Commission to take up with the Government, the request to reimburse to the Board the concessions so granted, as stipulated in section 65 of the Electricity Act 2003.
