The annual meeting of the Departmental Promotion Committee (Higher) for approving the Select List of Officers in the Electrical Wing for the year 2024 was held on 12/12/2023 and the Select List was published as per Proceedings read as (5) above

The nominations of certain Senior most Assistant Executive Engineers were not approved by the Committee during the annual meeting due to non satisfaction of eligibility criteria as prescribed in the Board Order read as (1) above .

At present 28 vacancies of Executive Engineer (Ele) exists and the vacancies have to be filled with the Senior most Assistant Executive Engineers from the DPC approved Select List. Before proceeding with the promotion, the nominations in respect of AEE's who have not been approved by the Committee have to be considered whether they have attained the eligibility to get included in the Select List so that in case are eligible ,their priority can not be overlooked.

Accordingly an Ad Hoc meeting of the DPC (Higher) was convened on 20/09/2024 and five nominations in the cadre of Senior most Assistant Executive Engineers together with their APAR,Vigilance Clearance and other eligibility criteria were placed before the Committee for enumeration .The Committee after examining the details has unanimously approved the nomination of the following Assistant Executive Engineer.

**Said Salim Palayi(1045401)**

Sri Said Salim Palayi ,Serial No.1 in the Select List read as (5) was Included as not approved with remarks that "Probation not declared and.No Vigilance Clearance ". His nomination has been approved in the ad hoc meeting with the condition that he will not be entitled for any retrospective claim with regard to his re instating of seniority/promotion

After convening the Ad Hoc DPC, the bench mark details of two more Assitant Executive Engineers ,Sri.Manoj Kumar P V (1048408) and Sr.Vijayakumar T.S (1046596) who were included in the Select List read as (5) as not approved on account of incomplete APAR have been received in complete and therefore those nominations also were circulated among the members of the Departmental Promotion Committee as per note read as (4) above and all the members have approved their nominations as follows
