**ORDER**

As per the decision taken in the Director Board meeting held on 22.06.2023, the Vigilance Wing of KSEBL has conducted an enquiry on the works in connection with the Rehabilitation of Vellathooval SHEP, executed by M/s Paulose George Construction Company Pvt Ltd.. The Vigilance wing had submitted a report as per the note read as 2<sup>nd</sup> above. The findings in enquiry were placed before 75<sup>th</sup> meeting of the Board of Directors. A detailed discussion on the findings was made in the meeting of the Director Board held on 18.12.2023 and it was suggested that the payment to the contractor cannot be held indefinitely pending. Also, disciplinary enquiry proceedings as suggested in the recommendations of Vigilance has to be proceeded in appropriate division. After discussing the matter in detail, the Director Board has:

1. Resolved to accord sanction for the payment to the contractor as per the Vigilance Enquiry Report for the amount arrived at ₹1.29 Crores (Rupees One Crore and Twenty Nine Lakh only).
2. Further resolved that based on the Vigilance Report appropriate action through respective officer shall be taken up
