ORDER

M/s. Royale Garden Hotels & Resorts (LCN.No.26/8275) is a non-live HT consumer which comes under Electrical Circle, Harippad. The HT service connection in respect of the consumer was disconnected on 04.07.2022 and dismantled on 10.05.2023 due to default of current charges. The consumer has an outstanding current charge arrears amounting to Rs.43,32,622/- as on 15.12.2023 (Principal- 40,75,371/- + Interest - Rs.2,57,251/-), after adjusting Rs.750000/- towards Bank Guarantee encashed on 09.08.2023) for the period of consumption month from 04/2020 to 12/2022.

Now the consumer as per letter read as 2nd above has requested for OTS Scheme sanctioned by KSEBL as per the Office Order read as 1st above. Accordingly, the matter was placed before the Full Time Directors, KSEBL as per the note read as 3rd above.

Having considered the matter in detail, the Full Time Directors resolved to permit the consumer M/s. Royale Garden Hotels & Resorts (LCN.No.26/8275) to clear the arrears under OTS Scheme 2023.

Accordingly, the outstanding current charge arrear amount has been recalculated and arrived as Rs.42,50,629/- (Arrear eligible for OTS Principal - Rs.19,48,391/- - with interest @ OTS rate Rs.40,996/- + Arrear not eligible for OTS Principal - Rs.21,26,980/- with interest @ normal rate Rs.1,34,262/-) as on 15.12.2023 at OTS rate with per day interest Rs.1369/- until the date of remittance in OTS 2023.

The OTS-2023 for the settlement of current charge arrears for the aforesaid amount is valid only if all litigation against the aforesaid arrears of current charges, if any, pending

before various judicial fora are withdrawn and on production of its documentary proof (Mandatory requisite in the OTS order dated 19.07.2023 in OP No.35/2023 of the Hon'ble KSERC).

The revenue recovery action already initiated will be withdrawn after full settlement of current charge arrears as per OTS 2023 and on production of receipt showing remittance of collection charges in the Taluk/ Village office concerned.

Non-compliance of this order will result in restoration of interest on delayed payment at normal rate of 18% Per annum and intensification of Revenue Recovery action for the recovery of current charge arrears.

Orders are issued accordingly.
