ORDER

Sri. Sadanandan Kunnathu, Superintendent (Rtd), Electrical Division, Kondotty, PPO No. 50953 has joined KSEBL service on 13.03.2001 FN as Cashier. He had prior service in Revenue Department from 10.11.2000 FN to 09.03.2001 AN. The above service was recorded and reckoned in the Service Book of the incumbent. He was relieved from the Revenue Department on 09.03.2001 AN and was supposed to join duty on 12.03.2001 in KSEBL. But he could join KSEBL service only on 13.03.2001 FN as 10.03.2001 and 11.03.2001 were second Saturday and Sunday respectively and Hartal was announced by the political parties on 12.03.2001. The whole batch of Cashiers/Junior Assistants joined duty on 13.03.2001 and hence he also joined duty on 13.03.2001.

As such there occurred a break in service of one day on 12.03.2001 which is not allowable as per the existing rules. Hence the Chief Engineer (HRM) as per note read as 2nd above has requested to condone the break in service of one day on 12.03.2001 in respect of Sri. Sadanandan Kunnathu.

In a similar case, KSEBL has accorded sanction to condone the break in service of Sri. Babu.M.K, Superintendent, Electrical Section, Parappukkara as per B.O. read as 6th above. This decision was taken in line with B.Os read 3rd, 4th and 5th above. The matter was placed before Full Time Directors as per note read as 7th above.

Having considered the matter the Full Time Directors have resolved to condone the break in service on 12.03.2001 in respect of Sri. Sadanandan Kunnathu, Superintendent (Rtd), Electrical Division, Kondotty in line with Board Orders 3rd, 4th, 5th and 6th above.
