## **ORDER**

Sri. M V Poulose retired from Board Service as Assistant Engineer on 29.02.1992 AN after rendering a Qualifying Service of 33 years. At the time of retirement family pension was sanctioned to his wife Smt P V Annamma. Though Sri. M V Poulose expired on 07.09.2019 Smt P V Annamma submitted application for family pension only on 25.02.2023.

As per the Affidavit read as  $4^{th}$  above Smt. P V Annamma stated that she could not submit the application for getting family pension due to Covid Pandemic period and that she was unable to move due to her illness. In order to sanction the arrears of family pension from 10/2019 to 04/2023, Board sanction is required as per Rule 136 Part III forwarded the documents read as  $1^{st}$  to  $4^{th}$  above for sanctioning the family pension arrears.

The matter was placed before the Full Time Directors as per note read as 6<sup>th</sup> above.

Having considered the matter in detail,the Full Time Directors through circulation has resolved to sanction Family Pension Arrear from 10/2019 to 04/2023 in respect of Smt. P V Annamma, W/o Late M V Poulose, Assistant Engineer(Rtd), PPO No.16643.
