ORDER

The Kerala State Pollution Control Board's integrated consent license to operate for KDPP had expired on 30.05.2023. An online renewal application submitted on 24.03.2023 accompanied with a payment of Rs. 9,08,000/- (Rupees Nine lakh eight thousand only) to extend the license for further one year till 30.06.2024 was not processed by the PCB due to online portal upgradation. The application resubmitted on 11.01.2024 through the new website, as per the instruction of PCB is currently pending with the PCB for approval.

The prospective approval of license will expire on 30.06.2024. According to PCB regulations, the renewal application has to be submitted three months in advance, which necessitates the submission of application by 31.03.2024. As per PCB "Consent to Operate" license is typically renewed for a period of five years and if renewal for a shorter duration is sought, appropriate justification must be provided, and prior consent from the PCB is to be availed. -

A hearing was held by the PCB Chairperson on 08.04.2024 in response to the submitted renewal application and directed KSEBL to further submit the renewal application for two years, up to 30.06.2025, accompanied by the compulsory fee of Rs. 9,08,000/- (including previous year application and balance amount) before 30.04.2024.

The Chief Engineer (Gen) requested sanction for the renewal of the Pollution Control Board license for the subsequent years, as it is imperative to adhere to statutory requirements to maintain the plant in an operational state.

The Director (Gen-Ele) placed the matter before the Full Time Directors as per note read as above and recommended to renew the 'integrated consent to operate licence' of KDPP for a period of one year from 30.06.2024 by remitting a fee of Rs.9,08,000/-.

Having considered the matter in detail, the Full time Directors resolved to accord sanction to renew "integrated consent to operate license" by Kerala State Pollution Control Board to

KDPP for the upcoming year from 30.06.2024 by remitting a fee of Rs.9,08,000/- (Rupees Nine lakh eight thousand only), as it is imperative to adhere to statutory requirements to maintain the plant in an operational state.

Orders are issued accordingly.
