ORDER

KSEBL accorded sanction as per B.Os read as 1st and 2nd above to procure 6 nos (3 nos for each region) of towable type transformer oil filtering plants of capacity 6000 LPH for the use of various substations at an estimated cost of Rs.2,04,38,782/- (all inclusive). The Chief Engineer (Transmission North) was authorized to invite tenders for the entire required quantity of 6 nos.

Accordingly, the Chief Engineer (Transmission North) invited tenders to procure 6 nos of mobile transformer oil filtering plants and purchase order read as 3rd above, was issued to the lowest bidder M/s CEE DEE Vacuum Equipments Pvt Ltd. at a unit rate of Rs.29,79,500/- (all inclusive) and total purchase price of Rs.1,78,77,000/- (all inclusive). The firm had supplied 6 nos. filter plants at 220kV Substations, Palakkad, Kaniyambetta, Chalakkudy, Kothamangalam, Kundara and 110kV Substation, Pathanamthitta, which were commissioned satisfactorily.

As per letter read as 4th above, the Chief Engineer (Transmission North) reported that one 6000 LPH mobile transformer oil filter plant each is urgently required for Transmission Circle, Kannur and Transmission Circle, Malappuram. The filtering plant for Kannur Circle is for the use of 220kV Substation, Ambalathara and nearby 110kV and 33kV substations, whereas the filtering plant for Malappuram Circle is intended for the use of 220kV Substation, Elankur and other nearby substations.

Hence, the Chief Engineer requested sanction for purchasing 2 nos of transformer oil filter plants by placing additional order with M/s CEE DEE Vacuum Equipments Pvt Ltd, Pune. As per Clause No. 11 of the purchase order with the firm, "purchase order for an additional quantity up to 25% over and above the original ordered or tendered quantity will be placed if the supplier is willing to supply the additional quantity at the same rate, terms and conditions of the original order". The firm had given their willingness to supply 2 nos. of filtering plants as additional order.

The matter was placed before the Full Time Directors as per note read as 5th above.

Having considered the matter in detail, the Full Time Directors resolved to accord sanction to purchase one no. of 6000 LPH mobile transformer oil filter plant from M/s. CEE DEE Vacuum Equipments Pvt Ltd. as additional order to the purchase order dated 10.03.2023 issued by the Chief Engineer (Transmission North) at the same unit price of Rs.29,79,500/- (all inclusive), for the use of Transmission Circle, Malappuram.

Orders are issued accordingly.
