Jyotheendranath.P, Assistant Executive Engineer (Electrical), Electrical Sub Division, Taliparamba who were undergoing treatment for the burns sustained due to the the arson attack in the Alleppy-Kannur Passenger Train at Elathur, Kozhikode on 02.04.2023.

Further as per the Government letter read as 2 nd above, it has been directed to submit the opinion of KSEBL regarding the grant of leave to Sri. Jyotheendranath.P, by forwarding the representation submitted by Smt.Deepa Chandrasekharan, W/o Sri.Jyotheendranath.P before the Hon'ble Chief Minister, Government of Kerala requesting to sanction Special Duty Leave to her husband stating that the unfortunate incident caused huge financial liability to the family.

The Chief Engineer (HRM) as per the note read as 3 rd above had further informed that Sri. Jyotheendranath. P has not submitted any medical claim on account of the above incident.

On examining the case, the Chairman and Managing Director had observed that due to sabotage the officers got injured and ordered to place the matter before Full Time Directores for decision considering this as a special case.

Accordingly the above matter has been placed before the Full Time Directors through circulation as per the note read as 4th above.

Having considered the matter in detail, the Full Time Directors resolved to sanction Special Leave t o Sri.Prakashan.A.V, Assistant Executive Engineer (Electrical), Electrical Sub Division, Pappinissery for a period of 14 days from 03.04.2023 FN to 16.04.2023 AN and Sri. Jyotheendranath.P, Assistant Executive Engineer (Electrical), Electrical Sub Division, Taliparamba for a period of 183 days from 03.04.2023 FN to 02.10.2023 AN who got injured at 1/38204/2024

the arson attack in the Alleppy-Kannur Passenger Train at Elathur, Kozhikode on 02.04.2023 by treating this as a special case.

Necessary entries in this regard shall be made in the Service Book of the employee.
