ABSTRACT

Handing over 0.4663 Ha of KSEBL land from the compound of 110kV Substation Malampuzha to NHAI in connection with construction of Palakkad - Kozhikode Greenfield Highway - Sanctioned - Orders issued.

ORDER

The Chief Engineer (Transmission North), as per letters read as 1 st above, reported that the alignment of proposed Palakkad - Kozhikode Greenfield Highway passes along the North East side of the boundary of 110kV Substation Malampuzha. Hence, land to an extent of 0.4663 Ha from the compound of 110kV Substation Malampuzha is under acquisition by NHAI in connection with the construction of Highway. The land owned by KSEBL is situated in Block No. 25, Survey No 153/8 (New survey 153/105) of Akathethara village in Palakkad district.

An amount of Rs.5,26,10,610/- has been awarded by the land acquisition authority to KSEBL towards the compensation for acquisition of land. The Deputy Collector, LA ordered that the title holder shall surrender and deliver possession of the land with all assets to the Competent Authority within 60 days of receipt of notice (06.03.2024) under section 3E (1) of the NH Act 1956.

The Chief Engineer (Transmission North) requested sanction for handing over the land to NHAI by accepting the compensation ordered by LA authorities. The matter was placed before the Full Time Directors for decision as per note read as 2nd above.

Having considered the matter, the Full Time Directors resolved to accord sanction to hand over 0.4663 Ha of land owned by KSEBL at 110kV Substation Malampuzha in Survey No. 153/8 (new Survey No. 153/105), Block No. 25 of Akathethara village, Palakkad district to National Highway Authority of India for the construction of proposed Palakkad-Kozhikode Greenfield Highway, by accepting the

compensation amount of Rs.5,26,10,610/- (Rupees Five Crore Twenty Six Lakh Ten Thousand Six Hundred and Ten only) awarded by the Competent Authority.
