ORDER

The Chief Engineer (HRM) as per note read as 1 st above has sought sanction for initiating disciplinary action against retired officials of Electrical Section Permpuzha in connection with financial loss incurred to KSEBL due to the wrong application of Multiplication Factor of M/s Nandanam Cashew Traders (con no: 1145851017177) under Electrical Section Perumpuzha A short assessment bill of Rs.8,48,009/- was issued to the consumer on 27.08.2021 for the period from 11/2019 to 06/2021.

The consumer approached CGRF against the above bill and CGRF as per order read as 3 rd above, directed the petitioner to make payment of the short assessment bill of Rs 8,48,009/- and also directed the KSEBL to allow 12 monthly installments to the petitioner without interest. Instead of remitting the bill amount, the consumer filed WPC 29240/2022 before the Honble High Court, which is still pending. The Deputy Chief Engineer, Electrical Circle, Kottarakkara as per report read as 3 rd above has reported that, out of the ten officials who were alleged responsible for the lapses, the three officials have already retired from the service of KSEBL.

As per rule 3 part Ill KSR, prior sanction of the Board is necessary to initiate departmental proceedings against the retired employees. The matter was placed before the Full Time Directors as per note read as 4th above. Having considered the matter, the Full Time Directors have resolved to accord sanction to initiate disciplinary action against the following retired employees icials invoking provisions contained as per Rule 3(b) and Rule 3(c) of Part Ill KSR.
