ORDER

Administrative Sanction was accorded as per proceedings read as 1 st above for the construction of a 33kV RMU substation at Elanad in Thrissur district and construction of 13km 33kV single circuit OH line using ACSR Dog conductor from 110 kV Substation Pazhayannur to the proposed 33kV Substation Elanad, at an estimate cost of Rs.498 Lakhs, with the objective of avoiding the supply interruptions and low voltage issues prevailing in the area and to provide reliable supply to meet the growing power demand in the area.

Technical Sanction was accorded as per proceedings read as 3 rd above for the construction of 33 kV RMU substation at Elanad by installing 1x5 MVA transformer and constructing 12km 33kV single circuit OH line using ACSR Dog conductor, laying 0.7km 33kV UG cable and drawing 0.75km 33kV single circuit OH line using covered conductor from 110 kV Substation Pazhayannur to the proposed 33 kV Substation Elanad, at an estimate amount of Rs.547 Lakhs, by including the provision for 33kV UG cable and covered conductor in areas belonging to Forest Department.

Sanction was accorded as per Government Order read as 4th above to hand over 5 cents of land in survey No.243 of Elanad Village owned by Pazhayannur Block Panchayath to KSEBL on lease basis for setting up the proposed 33kV substation.

The District Collector, Thrissur, as per order read as 5 th above, fixed a lease rent of Rs.3200/- per annum for the 5 cents of land and directed KSEBL to execute the lease agreement with Pazhayannur Block Panchayath.

The draft lease agreement was approved by the legal wing as per letter read as 6 th above and the lease agreement was executed by the Executive Engineer, Transmission Division, Thrissur with the Secretary, Pazhayannur Block Panchayath on 10.01.2024.

The Chief Engineer (Transmission North), as per letter read as 8 th above, requested sanction to take over the 5 cents of land in Survey No. 243 at Elanad Village, Thalappilli Taluk, Thrissur district from Pazhayannur Block Panchayath on lease basis for the construction of 33 kV RMU substation at Elanad at a lease rent of Rs.3200/- per year.

The matter was placed before Full Time Directors as per note read as 9 th above.

Having considered the matter in detail, the Full Time Directors, resolved to accord sanction to take over 5 cents of land in Survey No. 243 at Elanad Village, Thalappilli Taluk, Thrissur district from Pazhayannur Block Panchayath on lease basis for the construction of proposed 33 kV RMU substation at Elanad, at a lease rent of Rs.3200/- per year.

Orders are issued accordingly.
