**ABSTRACT**

Hiring a lorry of capacity 5 Ton and above on contract basis for the use of Transmission Circle, Kozhikode - Request for enhancement of monthly ceiling limit from 1500 km to 3000 km - Sanctioned - Orders issued.

**ORDER**

The Chief Engineer (Transmission North) as per letter read as 1<sup>st</sup> above reported that the hired vehicles attached to the Transmission Circle, Kozhikode usually exceeds the sanctioned monthly kilometer ceiling limit, due to the wide area of jurisdiction covering two districts Kozhikode and Wayanad and the need to transport materials from Transmission Store Angamaly to about 40 nos of Substations under the Circle.

Hence, the Chief Engineer requested sanction to enhance the monthly kilometer ceiling limit of the lorry with capacity 5 Ton & above attached to Transmission Circle, Kozhikode to 3000 km per month from the existing 1500 km per month, while inviting new tender. The Chief Engineer informed that, if the kilometer ceiling limit of the lorry having capacity 5 T and above is enhanced to 3000 km/month, the Transmission circle Kozhikode can manage with a single lorry instead of the existing two numbers, which is more beneficial to KSEBL.

The matter was placed before the Full Time Directors as per note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors resolved to accord sanction to enhance the monthly ceiling limit of the hired lorry with capacity 5 Ton and above attached to Transmission Circle, Kozhikode from 1500 km per month to 3000 km per month.

Orders are issued accordingly.


