ORDER

Administrative sanction was accorded as per B.O read as 1st above for the electrification of 261 PVTG (Partially Vulnerable Tribal Group) Households in 22 PE (Partially electrified) habitations with total project cost of Rs. 57.56 Lakh and the field officers were directed to proceed with the electrification of identified PVTG HouseHolds to ensure maximum utilization of fund before 31.3.2024 as per the scheme guidelines.

As per the "Mobile app data as on 03.01.2024" forwarded by M/s. PFC on 10.01.2024 field survey was done by the remaining field officers. The cost estimate for the unelectrified 55 nos PVTG households in 17 habitations in 4 districts of Kerala namely Kozhikode (11nos), Thrissur (10 nos), Malappuram (9 nos) and Palakkad (25 nos) amounting to Rs.2.473 Lakh was prepared and submitted to M/s. PFC on 02.02.2024.

During the $29^{\,\mathrm{th}}$ Monitoring Committee Meeting of Revamped Distribution Sector Scheme read as 2^{nd} above, the Monitoring Committee noted the proposal submitted by the Nodal Agency and the Committee approved the DPR for electrification of additional 55 PVTG Households in 17 PE habitations in KSEBL, Kerala with total project cost of Rs.2,47,300/-@ Rs.4496/- household and other applicable charges as per the scheme guidelines .

Administrative sanction was accorded as per the office order read as 3 rd above for the electrification of 55 PVTG Households in 17 PE (Partially electrified) habitations with total project cost of Rs.2.473 Lakh as per the DPR approved by the 29th Monitoring Committee Meeting of RDSS held on 21.02.2024 as per the scheme guidelines . The field officers were directed to proceed with the electrification of identified PVTG Households to ensure maximum utilization of fund. The
