ORDER

KSEBL as per B.O. read as 1st above has accorded sanction to hire or taken on lease five numbers of apartments with a maximum monthly rent of ₹25,000/- for accommodation of Directors of KSEBL in Thiruvananthapuram. Subsequently, apartment No. 3(A) at Cordial Corona, TC. No.XI/988(11), Nanthancode, Thiruvananthapuram was hired on monthly rental basis and being used for accommodation of one of the Directors. Upon expiry of the rental agreement, sanction has been accorded by KSEBL as per B.O. read as 2nd above to renew the lease agreement of the apartment for a period of 11 months with effect from 21.04.2023 at monthly rent of ₹29,000/- including maintenance charge.

The Chief Engineer (Civil-Construction) South as per note read as 3rd above has reported that the period of lease agreement of the above mentioned hired apartment will expire on 20.03.2024. It is also reported that the owner of the apartment has intimated his willingness to continue the agreement for a period of another 11 months at the same rent rate and terms and conditions.

The matter was circulated among the Full Time Directors as per the note read as 4th above.

Having considered the matter in detail, the Full Time Directors resolved to accord sanction for renewing the lease agreement of the hired apartment No. 3(A) at Cordial Corona, TC. No.XI/988(11), Nanthancode, Thiruvananthapuram for a period of 11 months with effect
