ORDER

The work "Design, Erection, Testing & Commissioning of Grid tied Solar PV project with total installed capacity of 11 MWp at various locations in KSEBL land" was awarded to M/s INKEL Ltd Cochin by the Chief Engineer (Renewable Energy & Energy Saving) under PMKUSUM component C scheme.

For the installation of 3.5 MWp solar plant at 220kV Substation, Mylatty as part of the above work, 617 nos of various trees located in the substation compound has to be disposed. The Assistant Forest Conservator, Social Forestry Division, Kasargode as per order read as 1st above has issued permission to cut and remove the trees and the value assessed by the Forest Department for the same is ₹17,41,646/-.

The Chief Engineer (Transmission North), as per letter read as 2nd above, requested sanction to the Survey Report No. 19/2023-24 amounting to Rs.17,41,646/- for the cutting and removal of the above said 617 no. of trees.

The matter was placed before the Full Time Directors for sanction as per note read as 3rd above.


