#### ORDER

Sri. T.C Yohannan while working as Sub Engineer of Electrical Major Section, Puthanathani was arrested on 10.10.2002 by the Deputy Superintendent of Police, Malappuram while demanding and accepting bribe of Rs. 1000/- from Sri.K.Unnikrishanan, a registered wireman for getting a UG Cable supply to the house of one Sri. P.K. Kunhippa of He was suspended from service for grave misconduct and dereliction of duty vide proceedings read as 1st above. A crime case was registered against him by Vigilance & Anti Corruption Bureau Unit, Malappuram under Section 7 and 3(1) (d) read with 13(2) of Prevention of corruption Act 1988. Later Sri. T.C Yohannan, Sub Engineer was reinstated in service as per proceedings read 2nd and was posted at Generation Circle, Moozhiyar. Memo of Charge with statement of allegation was issued as a part of the disciplinary proceedings which was kept in due to the pending finalization of vigilance case registered against him before the Hon'ble Enquiry Commissioner & Special Judge, Thrissur vide CC No.80/2008.

The Hon'ble Enquiry Commissioner & Special Judge, Thrissur as per Judgment in CC No.80/2008(VC.6/02/MLPM) dated 26.08.2013 had convicted him and sentenced to undergo rigorous imprisonment and to pay fine for the various charges levelled against him u/s 7 of Prevention of Corruption Act, 1988. As he was convicted by the court of law in a criminal case, he was liable to be removed from the Board's service as per rules. But Sri.T.C Yohannan had retired from Board's service on 31.05.2005 on superannuation. In continuation with the disciplinary action already initiated, KSEBL had the right to withhold or withdraw pension or part thereof for a specified period. Later it was decided as per proceedings read as 3<sup>rd</sup> above to withhold 50% pension permanently by invoking the provisions of Rule 2(a) & (b) KSR by reserving the right to review the punishment incase conviction is set aside by the Court.

Sri.T.C Yohannan had filed Criminal Appeal No.1306/2013 before the Hon'ble High Court of Kerala. During the pendency of the Criminal Appeal the appellant Sri.T.C Yohannan had expired on 03.03.2020 and his wife Smt. Rahelamma Yohannan was impleaded as additional appellant. The Hon'ble High Court vide Judgment dated 24.05.2023 read as 4th above had dismissed the Criminal Appeal and upheld the conviction of Hon'ble Enquiry Commissioner and Special Judge, Thrissur.

The matter was placed before the Full Time Directors as per note read as 5<sup>th</sup> above. Having considered the matter in detail and it was decided to discontinue the availing of family pension by Smt. Rahelamma Yohannan wife of late. T.C.Yohannan, forthwith.

Orders are issued accordingly.
