## ORDER

Sanction was accorded as per BO read as 1<sup>st</sup> above to depute 10 officers of KSEBL (8 officers under System Operation wirg and 2 officers under Transgrid) for attending the 8-day "Advanced training program on SAS & DIGSI 5 Engineering Tool" at Siemens Power Academy, Goa at an estimated cost of Rs. 11,00,000/-. It was also decided to book the expenditure under RDSS.

The offer for providing the training was given by Ms S.K.Automation Solutions, Thrissur, the channel partner of M/s Siemens Ltd. The Deputy Chief Engineer, System Operation Circle, Kalamassery, as per letter reac as 2<sup>nd</sup> above reported that the subject work was awarded to M/s S.K.Automation Solutions and contract agreement was executed by them. The training was successfully completed on 14.12.2022 and the expense in this regard is Rs.10.85,600/-.

Citing the information received from the O/o the Financial Adviser that the budget provision is not yet allocated for RDSS and that the modalities for passing the bills under RDSS have not been decided, the Deputy Chief Engineer requested sanction for releasing the payment of Rs. 10,85,600/- from the amount available under the sanctioned 'Operation & Maintenance' head of System Operation Circle, Kalamassery in the Budget Estimate 2022-23.

The Director (E, IT & SCM) opined to release the payment from KSEBL own fund and to reimburse the same from funds under RDSS, once sanction for "Capacity building" under

RDSS is obtained from MoP.

The Chief Engineer (IT, CR & CAPs), as per letter read as 5 <sup>th</sup> above, informed that the distribution in astructure works for loss reduction, smart metering, SCADA DMS for Kollam, Kannur & Thrissur towns have only been sanctioned under RDSS and Training and capacity building proposal have not been sanctioned. The Chief Engineer clarified that the amount incurred for the subject training cannot be met from the advance amount received as grant from Ministry of Power towards RDSS sanctioned works

The matter was placed before the Full Time Directors as per note read as 6th above.

Having considered the matter in detail, the Full Time Directors, in the meeting held on 13.03.2023 resolved to accord sanction to the Deputy Chief Engineer, System Operation Circle, Kalamassery to release the payment of Rs. 10,85,600/- (Rupees Ten lakh eighty five thousand and six hundred only) to M/s S.K Automation Solutions, Thrissur for providing the "Advanced training program on SAS & DIGSI 5 Engineering Tool", by charging the expenditure to the account of Institutional Development Programme.

Orders are issued accordingly.
