### ABSTRACT

#### ORDER

For continuing the construction activities of the Mankulam HEP components such as Power House, Switch Yard, P.H. Road, Surge, Valve House, Surge Road etc., the Eucalyptus Trees (285 Nos) standing in the leased forest area have to be cut and removed.

The Chief Engineer (Civil - Investigation & Construction Central), as per the note read as 2<sup>nd</sup> above, has reported that based on the request of the Project Manager, Mankulam HEP, the Divisional Forest Officer, Munnar has furnished a Demand Notice for remitting the value of 285 Nos. of Eucalyptus trees in the leased forest land amounting to Rs.13,45,118/- (Rupees Thirteen lakh Forty Five Thousand One Hundred and Eighteen only) including GST on value of timber through e-chalan (under BH-0406-01-101-99-05 other species).

The Chief Engineer (Civil - Investigation & Construction Central) has therefore requested to accord sanction for remitting the amount of Rs. 13,45,118/- to the Forest Department towards the tree value standing in the leased forest land, for the timely execution of the project.

The matter was placed before the Full Time Directors as per the note read as 3<sup>rd</sup> above. Having considered the matter in detail, the Full Time Directors in the meeting held on 28.12.2022, resolved to accord sanction for remitting the value of 285 Nos. of Eucalyptus trees standing in the leased forest area of Mankulam HEP, amounting to Rs.13,45,118/-(Rupees Thirteen lakh Forty Five Thousand One Hundred and Eighteen only) including Munnar through e-chalan under "BH-0406-01-101-99-05-other species" for the implementation of the Mankulam Hydro Electric Project.

Orders are issued accordingly.
