ORDER

The Deputy Chief Engineer, Electrical Circle, Manjeri as per letter read as 1st above reported that Sri. Moitheen Kutty had submitted an application in favour of his disabled son for getting concession in current charge. As per the B.O. read as 2nd above BPL family having cancer patients or permanently disabled persons as family members due to polio or accidents and consumes up to 100 units per month shall be billed at the rate Rs.1.50/unit, provided their connected load is of and below 1000 watts.

The connected load of the said consumer is 925 W and the average bi monthly consumption is 157units. The Assistant Engineer, Electrical Section, Pulamanthole reported that he had inspected the applicant's house for detailed enquiry and found that the petitioner's son is a permanently disabled person. As per the above B.O,the benefit can be given to a person who is permanently disabled due to polio but not considered about those who are disabled due to other reasons / bedridden. Hence the Assistant Engineer requested to consider him as a special case. The applicant had furnished income certificate from the Village Officer, Pulamanthole dated 25.08.2022 for an amount of Rs.48000/- per annum, which is below Rs.50000/- copy of ration card and the certificate of Disability dated 15.06.2022, District Hospital, Perinthalmanna showing 80% disability and affected part of body as per diagnosis -Brain, Spastic Cerebral, Palsy, Tetra Plegia.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having examined the matter in detail, the Full Time Directors in the meeting held on

18.01.2023 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Manjeri to allow concession in current charges to Sri. Moideenkutty under Electrical Section, Pulamanthole (Consumer No 1165642014244) C/o his son Sri. Muhammed Ajmal (25yrs) having 80% disability- (affected part of body as per diagnosis-Brain, Spastic Cerebral, Palsy, Tetra Plegia), who belongs to BPL family and consumes up to 100 units per month may be billed at the rate Rs.1.50/unit as their connected load is of and below 1000 watts, considering the poor financial condition of the beneficiary as a special case.

Further resolved to direct the Executive Engineer, Electrical Division, Perinthalmanna to ensure that the concession given for bimonthly consumption up to 200 units is accounted in the head of accounts 28.625 as per the proceedings No. Annual Accounts-IX/AC-II/2/2012-13 dated 07.11.2012 of the Financial Adviser, so as to claim this from the Government.

Orders are issued accordingly.
