ORDER

The 7th Monitoring Committee Meeting of RDSS held on 15.03.2022 have approved the DPR proposal of KSEBL. In the first phase, implementation of SCADA DMS (Distribution Management System) project in Group A towns viz Kollam, Thrissur & Kannur under KSEBL and TCED has been sanctioned under loss reduction works by PFC/MoP as per letter read as 1st above for a sanctioned cost of Rs.243.36 Crore. The administrative sanction (AS) has been accorded as per B.O. read as 2nd above,for the loss reduction DPR proposals along with SCADA DMS for SCADA Group A towns. SCADA Project Management Agency (PMA) has been selected for the RDSS SCADA projects in Kerala through etendering and LoA has been issued to M/s WAPCOS Ltd on 07.09.2022.

KSEBL has floated RFP read as 3rd above for SCADA under RDSS as single tender for SCADA Group A and B towns on 03.03.2023 so as to ensure the selection of a single bidder for SCADA Implementation Agency (SIA). Even though the bid submission was extended 13 times, no bidder has participated in the tender for the selection of SCADA implementing Agency (SIA) of Group A and B towns under RDSS. Later the tender was cancelled through Corrigendum dated 28.09.2023, as PFC has published revised SBD for RDSS SCADA. Further in line with the revised SBD, RFP read as 4th above for SIA was floated on 14.11.2023 for SCADA Group A towns. The prebid meeting was conducted on 29.11.2023 and more than 15 firms participated. Only two bidders only participated in the tender, even though the bid submission date was extended 8 times. As per the Minutes of the Pre-Qualification Committee read as 9th above, M/s. Konkan Railway Corporation Limited (KRCL) is the sole qualified bidder.

The Chief Engineer (IT, CR & CAPs) as per notes read as 10th above, placed the matter before the Full Time Directors for decision.

Having considered the matter in detail, the Full Time Directors in its meeting held on 08.07.2024, resolved to retender the selection of SCADA Implementation Agency for implementation of SCADA/DMS project in Group A towns in Kerala under RDSS scheme with pre-bid meeting and with open tender.

Orders are issued accordingly.
