## ABSTRACT

Transportation, loading & unloading of raw materials for fabrication works from suppliers and transportation, loading and unloading of finished line materials, A poles and other materials from CMF Pallom/MF1 Angamaly/MF2 Kolathara to various locations by trailors and lorries for a period of 2 years - Time extension up to 31.08.2024 or up to the commencement of the new work, whichever is earlier - Sanctioned - Orders issued.

## ORDER

Technical sanction was accorded as per B.O. read as 1<sup>st</sup> above, for an amount of ₹9,42,00,000/- for the subject work. As per B.O. read as 2<sup>nd</sup> above, the contract was

awarded by the Deputy Chief Engineer & Principal Team Leader, Civil Circle, Pallom to M/s. K. A. Associates, Angamaly, for the Transportation, loading & unloading of raw materials for fabrication works from suppliers and transportation, loading and unloading of finished line materials, A poles and other materials from CMF Pallom/ MF1 Angamaly/ MF2 Kolathara to various locations by trailors and lorries for a period of 2 years from 01.05.2022 to 30.04.2024, with a contract amount of ₹10,98,20,961/-(including GST), and Work Order read as 3<sup>rd</sup> above was issued.

The Deputy Chief Engineer & Principal Team Leader, Civil Circle, Pallom reported, as per papers read as 8<sup>th</sup> above that the agreed completion period for the subject work expired on 30.04.2024. This period was extended up to 30.06.2024 or up to the commencement of the new work, whichever is earlier as per the Office Order read as 5<sup>th</sup> above. Administrative sanction for the estimate for next tender was issued as per B.O. read as 6<sup>th</sup> above, and tender read as 9<sup>th</sup> above has been invited from Civil Circle, Pallom. The contractor has expressed their willingness to continue the work up to 31.08.2024 as per letter read as 7<sup>th</sup> above with the same rate and conditions of the agreement. If the present contract is not continued, the transportation of materials to Distribution and Transmission wings will be stopped altogether, as there are no alternative arrangements for the transportation of the materials at present. In the light of these circumstances, it is desirable to continue the transportation works under the present contract up to 31.08.2024 or up to the commencement of the new work, whichever is earlier.

Hence the Deputy Chief Engineer & Principal Team Leader, Civil Circle, Pallom has requested sanction to extend the present contract period of the subject work up to 31.08.2024 or up to the commencement of the new work whichever is earlier, with the same rate, terms and conditions of the original contract so as to continue the work without affecting the work of Distribution and Transmission wing.

This matter has been reported to the Director (D,S,P&SCM) as per note read as 10<sup>th</sup> above and the Director (D,S,P&SCM) has directed to place the matter before the Full Time Directors.

This matter was subsequently placed before the Full Time Directors as per note read as 11<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors resolved to accord sanction to extend the contract period of the work of transportation, loading and unloading of raw materials, for fabrication works from suppliers and transportation.

loading and unloading of finished line materials, A poles and other materials from CMF Pallom/MF1 Angamaly/MF2 Kolathara to various locations by trailers and lorries upto 31.08.2024 or upto the commencement of the new work, whichever is earlier, with the same rate, terms and conditions of the original contract as requested by the Deputy Chief Engineer & Principal Team Leader, Civil Circle, Pallom, since there are no alternate arrangement for the transportation of materials at present and tender for the new work (2024-26) is in progress.
