## **ORDER**

M/s Airtel and M/s VI (Vodafone Idea), the service providers of KSEBL for meter communication and SCADA operation has requested for M2MSP (M2M Service Providers) registration for using their M2M (Machine to Machine) SIMs.

The Department of Telecommunications (DoT) has issued guidelines for the registration of M2M Service Providers, making the M2MSP registration mandatory for all companies providing M2M services. As per the guidelines all entities providing M2M services need to complete their registration by 31<sup>st</sup> March 2024.

M/s. Airtel as per e-mail read as 1<sup>st</sup> above has clarified that M2MSP registration is mandatory for utilities like KSEBL which uses M2M services either for captive use or for third parties. The M2MSP registration is to be done through the Saral Sanchar portal (https://saralsanchar.gov.in). For this registration, it is required to upload a Letter of Authorization (LoA) in the format issued by the Department of Telecommunications (DoT).

The matter was placed before the Full Time Directors as per note read above for authorising Chief Engineer (IT, CR & CAPs) for M2MSP registration in Saral Sanchar portal and for issuing a Letter of Authorization (LoA) in the name of Chief Engineer (IT, CR & CAPs).

Having considered the matter in detail, the Full Time Directors, in the meeting held on 19.07.2024,

- a. Resolved to authorize the Chief Engineer (IT, CR & CAPs) for M2MSP registration in the Saral Sanchar portal.
- b. Further resolved to accord sanction to issue a Letter of Authorization (LoA) in the name of the Chief Engineer (IT, CR & CAPs) through a resolution passed as per the format provided by the Department of Telecommunications.
