## ORDER

The Deputy Chief Engineer with full powers of Chief Engineer, Civil Circle, Meencut has reported as per letter read as 1<sup>st</sup> above that the Executive Engineer, Project Division, Kerala Water Authority, Kattappana made a request to the Project Manager, Mankulam HEP to accord permission for laying water line through the power house road of Mankulam HEP from Perumbankuthu to Kurathikudy for providing potable drinking water to the Kurathikudi tribal settlement area which is included in Jal Jeevan Mission project. In this regard the Project Manager, Mankulam HEP has reported that the said 4.5 km length road to powerhouse is passing through the forest land and the land is leased out by KSEBL from Forest Department. It is also reported that the request of KWA for laying water line through the powerhouse road is genuine as no other alternate route is available.

The Director (Generation-Civil) has reported that permission was already granted to M/s. BSNL as per B.O. read as 2<sup>nd</sup> above for laying underground optical fibre cable through the powerhouse road for a length of 6.75 km from Perumbankuthu to Kurathikudi through Mankulam powerhouse road for facilitating 4G network connectivity to Kurathukudi tribal settlement and that work is progressing.

The Deputy Chief Engineer with full powers of Chief Engineer, Civil Circle, Meencut has requested as per letter read as 1st above to accord sanction for laying water line

through the powerhouse road of Mankulam HEP from Perumbankuthu to Kurathikudy for providing potable drinking water to the Kurathikudi tribal settlement area which is included in Jal Jeevan Mission project.

The matter was placed before the Full Time Directors as per note read as 3 rd above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 16.08.2024 resolved to accord sanction for laying water line through the powerhouse road of Mankulam HEP from Perumbankuthu to Kurathikudi for providing potable drinking water to the Kurathikudi tribal settlement area which is included in Jal Jeevan Mission Project subject to necessary clearance from Forest Department.
