**ORDER**

Sri. Ashokan. C.A. had made a complaint before the Hon'ble DLSA Waya nad as PLP (D) 2019/2023, wherein it was alleged that KSEBL had drawn a electric line over and above the house of his sister Smt. Sarojini and there were some serious safety issues to her family. The petitioner's demand was to shift the line from the property of Smt. Sarojini on KSEBL's own cost. Consequently the DLSA, directed the Project Officer, ITDP to find out fund to meet the expense for the same. Later, the matter was brought before the ADM, Wayanad. After hearing the parties, the ADM issued orders by virtue of powers conferred up on her by Indian Telegraph Act 1885, wherein KSEBL, was directed to carry out the shifting work at its own cost.

The matter has been placed before the Full Time Directors as per note read as 2<sup>nd</sup> requesting sanction for compliance of the order of the ADM.Having considered the matter in detail,the Full Time Directors passed the following resolutions

- a. Resolved that, as a special case,since there is other feasible route, the order of the

Additional District Magistrate, Wayanad dated 26.06.2024 to the Assistant Executive Engineer, Electrical Sub Division, Kalpetta to shift an electric line drawn over the house of an 'Adivasi' family in the expenses of KSEBL, shall be complied with at a cost of Rs.17,903/- as estimated by the Assistant Executive Engineer, Electrical Sub Division, Kalpetta.

- b. Further resolved to take up the matter with Tribal Department for reimbursement of the cost of Rs.17,903/-.
