ORDER

The Government of India had directed to implement the Pallivasal Pumped Storage project and Idukki pumped storage project in Kerala through M/s. THDCIL. When discussions was being held on the modalities of implementation of the schemes through formation of Joint venture, decision was taken by the State Government for development of Pumped Storage projects by KSEBL instead of implementing through THDCIL. The proposals for implementation of Pumped Storage Schemes and standalone projects of Idukki Golden Jubilee Scheme and Letchmi HEP were placed before the Director Board to take a decision on the prioritization of the projects . A detailed presentation of the same was held in the Director Board meeting held on 30.09.2023.

After discussion of the matter in detail, the Director Board in the meeting held on 30.09.2023:

Resolved to accord in principle approval to take up the project Letchmi HEP (240 MW) with CEA for approval and preparation of DPR through EPC mode.

Resolved further that the implementation of Idukki Golden Jubilee Scheme (800 MW) shall be prioritized.

Also resolved that detailed project report of Idukki Pumped Storage Scheme (700 MW),

Pallivasal Pumped Storage Scheme (600 MW) and Idamalayar Pumped Storage shall be prepared by examining feasibility and priority from the point of view of cost and time for executions.

Orders are issued accordingly.
