KSEBL as per B.O read as 1st above has accorded sanction for confirming the auction for disposing 200 Nos. of trees located at various sites of the Upper Sengulam Hydro Electric Project in favour of Sri. Sajan K.V., Kadayam House, Mangadavu, Koombanpara P.O., at his offered rate of Rs.70,000/- (Rupees Seventy Thousand only) plus applicable taxes.

It is noticed that an error had crept in the decision of the above order due to misprint, that, instead of sanction for confirming the auction for disposing 220 Nos. of trees located at various sites of the Upper Sengulam Hydro Electric Project, sanction was accorded for confirming the auction for disposing 200 trees.

The matter was placed before the Full Time Directors as per note read as 2nd above for decision.

Having considered the matter in detail, the Full Time Directors resolved to accord sanction to modify the decision of the B.O. (FTD) No. 503/2023 (DGC/AEEV/Up-Sen/2015) dated 28.11.2023 as "to accord sanction for confirming the auction for disposing 220 Nos. of trees located at various sites of the Upper Sengulam Hydro Electric Project in favour of Sri. Sajan K.V., Kadayam House, Mangadavu, Koombanpara P.O., at his offered rate of Rs.70,000/- (Rupees Seventy Thousand only) plus applicable taxes."


