ORDER

The Chief Engineer (Distribution Central), Ernakulam as per the letter read above has reported that the departmental Mahindra jeep KL 07G- 5159 is 1994 make (29 years old) and the last registration was done on 14.06.2019 and the insurance is up to 05.05.2023. From 30.09.2023 onwards the jeep was garaged by complying the directions issued by the Motor Vehicle Department and to avoid penalties etc. The subject jeep is neither economical nor road worthy and hence it is directed to dispose the same by auction at the earliest so as to receive a good sum before deterioration of the same.

It is reported that even after repeated tendering process to hire a contract jeep with monthly ceiling limit of 1500 km, the same doesnot yield any positive response from the contractors and at present a jeep is being arranged temporarily for 3 months period and the average monthly run is around 1750 km.

Considering this, the Chief Engineer (Distribution Central) requested to hire a contract jeep with a monthly ceiling limit of 1750 km since it is more economical to KSEBL.

Hence, the matter was placed before the Full time Directors as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors, resolved to accord sanction to enhance the monthly existing kilometer limit of the hired jeep attached to Electrical Section, Angamaly under Electrical Circle, Perumbavoor from 1500 km to 1750 km for the smooth functioning of the office.

Orders are issued accordingly.
