The Chief Engineer, Distribution South as per note read as 2nd above, has forwarded an estimate and requested sanction to meet the contingency expenditure (for the deployment of staff for duty at Sabarimala, Pampa and Nilakkal) for an amount of Rs.3,98,280/- (Rupees Three lakh ninty eight thousand two hundred and eighty only) under Electrical Section, Ranni Perunad and Rs.1,58,700/- (Rupees one lakh fifty eight thousand and seven hundred only) under Electrical Section, Kakkad, in connection with the Sabarimala Mandalam Makaravilakku Festival 2023-24.

The matter was placed before the Full Time Directors as per the note read as 3rd above.

Having considered the matter in detail, the Full Time Directors resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Pathanamthitta, to meet the contingency expenditure in connection with the Sabarimala Mandala Makaravilakku Festival Season 2023-24, under Electrical Sections, Ranni-Perunad and Kakkad, at an estimated cost of total expenditure of Rs.5,57,000/- (Rs. Five Lakhs Fifty Seven Thousand only).
