## **ORDER**

As per the Circular read as 1<sup>st</sup> above, it was directed that all officers and workmen of KSEBL shall contribute an amount equivalent to at least five days salary to the Chief Minister's Distress Relief Fund (CMDRF) in connection with 'Rebuild Wayanad'. It was also directed that the above amount shall be recovered in three installments from September 2024 onwards.

The Financial Adviser has, vide note read as 2 <sup>nd</sup> above, informed that recovery towards CMDRF is being processed at the ARUs of KSEBL, and therefore, the consolidated amount will be available at the Head Office only upon submission of Monthly Accounts by the ARUs, which may take some time. Given the importance of timely remittance of the recovered amount for its intended purpose, the details were extracted through the IT Wing. The recovery for the month of September is reported as Rs.4.46 Crore. Considering that the five day salary recovery is being made in three monthly installments at a ratio of 1:2:2, commencing from September 2024, and that the recovery process has already begun, the Financial Adviser has proposed that KSEBL may remit Rs.10 Crore as an advance to the Chief Minister's Distress Relief Fund in September 2024. The balance may be remitted after the actual recovery is completed.

The Financial Adviser has also recommended that the Secretary (Administration) may be authorised to remit the above contribution to the Chief Minister's Distress Relief Fund through account payee cheque.

Having considered the matter in detail the Full Time Directors resolved to accord sanction for the following:

- 1. To transfer Rs.10,00,00,000/- (Rupees Ten Crore Only) to the Chief Minister's Distress Relief Fund during the month of September, 2024.
- 2. To authorise the Secretary (Administration) to transfer the contribution to Chief Minister's Distress Relief Fund through account payee cheque.

Orders are issued accordingly.
