## **ORDER**

The Chief Engineer (Transmission North), as per letter read as 1<sup>st</sup> above, reported that the Executive Engineer, Transmission Division, Malappuram had invited competitive tenders for hiring a Tempo Traveller for the use of Transmission Section, Malappuram for a period of one year. Three tenderers participated in the tender and the lowest rate was quoted by Sri. Abdul Saleem, Sabeena Manzil, Areekode. The rate quoted is Rs. 30/km. After negotiation at various levels, he reduced the rate to Rs.28.25/km.

The Chief Engineer reported that considering the hill tract area and the hike in fuel price, spare parts etc, the quoted rate is reasonable and requested to award the work to the lowest bidder at his negotiated quoted rate. The matter was placed before the Full Time Directors for sanction as per note read as 2<sup>nd</sup> above.

Having considered the matter, the Full Time Directors, resolved to accord sanction to finalise the tender for hiring a Tempo Traveller for the use of Transmission Section, Malappuram for a period of one year with the lowest bidder Sri. Abdul Saleem K, Sabeena Manzil, Arekkode at his negotiated quoted amount of Rs.42,375/- per month upto 1500km (@ Rs.28.25/km) and Rs.28.25/km for every additional kilometer beyond 1500km.
