ABSTRACT

Hiring of vehicle (Diesel Jeep) with driver for the use of Transmission Construction Section. Chengannur under Transmission Circle, Alappuzha - Extension for two more years -Sanction Accorded - Orders issued.

ORDER

Sanction was accorded as per B.O. read as 1st above for hiring a vehicle (Diesel Jeep or equivalent) with driver on contract basis for the use of Transmission Construction Section, Chengannur with a monthly ceiling of 1500km for a period of two years or till the completion of the work, whichever is earlier. The contract period of the hired vehicle is completed on 27.10.2023.

The Chief Engineer (Transmission South), as per note read as 2nd above, reported that since many major capital works are currently being carried out by the Transmission Construction Section, Chenagannur, the period of hiring the vehicle (diesel Jeep) need to be extended for a further period of two years from 28.10.2023 or till completion of the projects, whichever is earlier. The financial commitment for hiring the vehicle with driver for 2 years is estimated as Rs.8,49,600/- (including GST) at the prevailing Board approved rates, with a monthly kilometer ceiling of 1500 km.

Considering the necessity of a vehicle for the smooth functioning of the Transmission Construction Section, Chenagannur, the matter was placed before the Full Time Directors for sanction as per note read as 3rd above.

Having considered the matter, the Full Time Directors, resolved to accord sanction to extend the period of hiring of vehicle (diesel Jeep or equivalent) for the use of Transmission Construction Section, Chengannur for a further period of two years from 28.10.2023 or till completion of the capital works handled by the Transmission Construction Section, whichever is earlier, by charging the expenses on this account to the respective capital works.

Orders are issued accordingly.
